Notice to file claims and objections
as per Cantonment Electoral Rules 2007

1. The preliminary electoral roll of voters for the Cantonment Ahmedabad is open to inspection at the Cantonment office daily between 11am to 4pm upto 16-08-2018.
2. Any person who claims to be entered in this roll and who is not entered therein or is entered in an incorrect place or with incorrect particulars may put in a claim addressed to the Chief Executive Officer to have his name entered, or the registry corrected, as the case may be.
3. Any person whose name is borne on this roll and who objects to the inclusion of his own name, or that of any other person whose name is on the roll, may prefer the objection against inclusion of name under rule 13(3) in prescribed proforma as per form no.(iv) addressed to the Chief Executive Officer.
4. Claims shall be preferred in form III as per rule 13(2) and objections in Form IV as per rule 13(3) or Form IV-A as per rule 13(4) appended to this notice and must be signed by the claimant or objector or by his duly authorized agent. Copies of the forms will be supplied free by the Chief Executive Officer on application.
5. Claims and objections may be presented to the Chief Executive Officer at any time during office hours or sent by post but it must reach him within twenty days from the date of issue of this notice i.e. on or before 20-07-2018 as per rules 13(1).
6. Claims and objections which are not found to be in prescribed format or in the proper form or which have not received on or before 20-7-2017 will be rejected by the CEO as per rule 13(7).
7. The list of claims and objections which shall be found or considered valid by the CEO and which have been received on or before 20-07-2017 shall be published in form V not later than three days i.e. 23-07-2017 from last date of receipt of claims and objections i.e 20-07-2017 as per rule 15(1).
8. All claims and objections received in time and in proper form will be heard by the President, Cantonment Board or his nominee as per rule 15(3) at Ahmedabad Cantonment Board office on a suitable date as conveyed by the PCB.
9. Order of the nominee of the President shall be final subject to result of an appeal if any made within two days to the President when order passed by his nominee as per rule 15(4).
